Street Collection: Guidelines and Request Form (Last revision June 2026)

Please read the following notes carefully and seek advice if necessary, before taking any action in relation to your collection request.

- * Your request to collect should be submitted to City Hall, 200 East Market Street, Red Bud, IL 62278 a minimum of 45 days before your intended collection date by completing the attached form. All requests are approved by the City Council. City Council meetings are generally held at 6:00 p.m. the first Monday of each month but are subject to change with a minimum of 48 hours notice to the public.
- * Authorization to conduct a street collection will be considered by the City Council of the City of Red Bud, IL. If approved, the collection can only be conducted between the hours, within the area specified, and on the date(s) approved by the City Council.
- * No one under the age of 16 years will be permitted to collect or sell.
- * The name organization or group sponsoring the collection and the purpose of the collection must be visibly displayed at all times during the collection for all motorists providing a minimum of 50 feet notice ahead of the location of the collection.
- * A certificate of liability insurance naming the City of Red Bud, IL as additional insured will be required for the date(s) of the collection.
- * Anyone collecting must wear adequate reflective gear to ensure that they are visible to all motorists at all times and must stand at least 3 car lengths from the main intersection.
- * The City Council reserves the right to attach additional stipulations when approving any collection request submitted.
