**That the liquor establishment has named a raffle manager who will be responsible for and in charge of all raffle chances sales and conducting all raffles within the liquor establishment; and**

That no persons managing or operating raffles at the liquor establishment will receive any remuneration or any other compensation for their participation, either directly or indirectly from any source; and

**That the liquor establishment shall not allow any organization who does not hold a raffle license from the City of Red Bud to sell any chances or conduct any raffles in their liquor establishment. The liquor establishment shall be held responsible for ensuring any organization possesses a valid and current raffle license. Violation of this requirement may result in the revocation of the liquor establishment's license to sell raffle chances.**
