ORDINANCE NO. 1547

**AN ORDINANCE AMENDING  
TITLE IX, CHAPTER 90 OF THE CITY OF RED BUD  
CODE OF ORDINANCES 2021  
PERTAINING TO ANIMAL CONTROL OFFICER**

WHEREAS, the City of Red Bud has the power to appoint officers with the advice and consent of City Council; and

WHEREAS, the method of making this appointment is not efficient; and

WHEREAS, the City of Red Bud finds that there is a need, and that it is in the best interest of the City of Red Bud to formally revise the procedure for appointing officers and their successors; and

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF RED BUD, ILLINOIS:

**SECTION 1:** That the above recitals are hereby made a part of this Ordinance as though written herein verbatim.

**SECTION 2:** That Section 90-1 of Chapter 90 of the Revised Code of Ordinances of the City of Red Bud is repealed and replaced with the following:

**90-1: ANIMAL CONTROL OFFICER ESTABLISHED.** There is hereby created the position of Animal Control Officer, who shall be a resident of the City, over the age of twenty-one (21) years and shall be hired by the Mayor with the advice and consent of the City Council. He shall receive compensation as set forth by the City Council.

**SECTION 3:** This Ordinance supersedes all Ordinances or parts of Ordinances adopted prior hereto that are in conflict herewith, to the extent of such conflict.

**SECTION 4:** This Ordinance shall be in full force and effect from and after its passage, approval, and signature by the Mayor.


