ORDINANCE NO. 1553

**AN ORDINANCE AMENDING TITLE IX, CHAPTER 93 OF THE
CITY OF RED BUD CODE OF ORDINANCES 2021
PERTAINING TO PARKS**

WHEREAS, the City of Red Bud Code of Ordinances 2021 includes Chapter 93 which involves Parks; and

WHEREAS, Chapter 93 includes rules and regulations for reserving shelters in City parks;

WHEREAS, the method of making waiving fees for shelter reservations is not efficient; and

WHEREAS, the City of Red Bud has deemed it in the best interest of the City to amend the rules and regulations for the reservation of shelters to streamline the process of waiving fees for certain applicants.

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF RED BUD, ILLINOIS:

SECTION 1: That the above recitals are hereby made a part of this Ordinance as though written herein verbatim.

SECTION 2: That Section 93-8(E) of Title IX, Chapter 93 of the City of Red Bud Code of Ordinances 2021 of the City of Red Bud, Illinois be repealed and replaced with the following:

(E) Picnics. No person shall picnic in the municipal parks, except in areas designated for that purpose. Park personnel are hereby authorized to regulate the activities in such areas when necessary to prevent congestion or to secure the maximum use, comfort, and convenience of all. Visitors shall comply with any directions given to achieve this end. Any person may reserve a shelter by applying for a reservation at the City Hall and paying a reservation fee per fee schedule as determined from time to time. The following groups may reserve a shelter by applying for a reservation at the City Hall and will have the fee waived: not-for-profit organizations, schools, and churches.

SECTION 4: This Ordinance supersedes all Ordinances or parts of Ordinances adopted prior hereto that are in conflict herewith, to the extent of such conflict.

SECTION 5: This Ordinance shall be in full force and effect from and after its passage, approval, and publication in pamphlet form, as provided by law.




