Cincinnati Insurance Company notified the city of nonrenewal, due to the city not having any other policies with their company. IRMA-Travelers Insurance has done a risk assessment but has not returned a final quote as of 3:00PM today. IRMA is essentially the city's only option for boiler coverage. The Cincinnati policy was \$15,660 a year for the past three years.
